During the 2019-2020 school year, students will receive a free breakfast and lunch meal under "Community Eligibility Provision." A la carte menu items will also be available at a nominal price. The Food & Nutrition Services Department encourages students to take advantage of the free meals and low cost nutritious a la carte items.
